BACKGROUND & JUSTIFICATION:

The City of Marathon issued a Request for Qualification (RFQ-03-0-2024/LF) for "Design of Class I Deep Well and Appurtenances" on June 12, 2024, with sealed bids opened and publicly read on August 8, 2024.

The Class I Deep Well Project Scoring Memo is attached as Exhibit "A" lists the responses from the Bidders. City staff, recommends approval the ranking listed in the Scoring Memo and The City Manager To enter into negotiations On Behalf Of The City with the highest ranked firm and the second ranked firm should the city not reach agreement with the highest ranked firm; And Providing For An Effective Date.

Mr. Saus,

The City of Marathon published a Request for Qualifications for design, permitting and construction phase services of its planned effluent disposal deep injection well. Two firms submitted Statements of Qualifications (SOQs). These firms are:

- Water Science Associates (WSA)
- McNabb-Miller Hydrogeologic Consulting, Inc. (MMHC)

Both firms were found to be responsive and responsible. A review panel consisting of three qualified individuals designated by the City reviewed and scored the SOQs independently and provided scoring in accordance with the RFQ requirements. The table below tallies the scoring by the individuals and provides the average overall score for each firm.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING THE RANKINGS FOR FIRMS RESPONDING TO THE RFQ FOR "DESIGN, BIDDING AND CEI SERVICES FOR THE CLASS I DEEP INJECTION WELL PROJECT" AND TO ENTER INTO NEGOTIATIONS WITH THE HIGHEST RANKED FIRM WITH APPROVAL TO USE THE SECOND RANKED FIRM SHOULD THE CITY BE UNABLE TO NEGOTIATE AN ACCEPTABLE COST WITH THE HIGHEST RANKED FIRM; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Marathon (the "City") issued an Request for Qualification (RFQ-003-0-2024/LF) on June 12 ,2024 for "Design of Class I Deep Well and Appurtenances", (the "Project"); the bids were unsealed and read aloud at City Hall on August 8, 2024; and

WHEREAS, Two bidders, Water Science Associates and McNabb-Miller were both found to be responsive and responsible, and where Water Science Associated scored the highest on the RFQ review,

WHEREAS, the City staff wish to enter into negotiations with the highest ranked firm and the second ranked firm should the city not reach agreement with the highest ranked firm; in order to provide a design, permitting, and CEI Services for the Class I Deep Well Project; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The foregoing recitals are true and correct and are incorporated herein by this reference.

Section 2. The recommendations attached hereto as Exhibit "B", together with such nonmaterial changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney is hereby approved. The City Manager is authorized to negotiate the cost of the work and to bring the Contract back to Council for final approval.

Section 3. This resolution shall take effect immediately upon its adoption.
