Monthly Report: July 2024

Dear Council:

Deputies focused on road safety and DUI enforcement, ending the month with an impressive 15 DUI arrests, 655 traffic stops, issuing 269 citations. 75 physical arrests were made, and 19 Notice to Appear were issued in June.

Deputy Guerra and Deputy Guardinu worked diligently on resource violations throughout the month of June issuing multiple resource citations and safety citations. Deputy Guerra issued 8 at risk vessel citations and 10 expired registration vessel citations in an effort to deter additional vessels from becoming derelict.

Deputy Marino led the district with 5 DUI arrests, and multiple narcotic offenses. The district was active throughout the month with community policing and zone improvements.

CIU's clearance ended the month with a 61% clearance rate closing over 20 vessel burglary cases. Overall, Deputies in District 4 continue to work hard.

### **Crime/Arrest Report:**

#### **MCSO24OFF004093 Grand Theft Auto – Valero Gas Station**

Andrew Parizo was arrested following an investigation into a stolen vehicle from Valero Gas Station. The victim parked his vehicle in the parking lot and went inside the gas station. When he exited, he discovered his vehicle was gone. Detectives reviewed surveillance, observed the offense, and were able to ascertain an image of the suspect. It was also discovered that the suspect had arrived in another vehicle prior to committing the offense. A BOLO was issued and a few days later, patrol located Parizo and the suspect vehicle. Parizo admitted to theft post Miranda Warning and was placed into custody.



## Vessel Burglary Spree

Daniel Aleman, Ryan Oliu, and Dadrian Aleman were arrested following a spree of vessel burglaries beginning in September 2023. Detectives had a break in the cases when a suspect vehicle was identified. Through investigation, the vehicle was discovered to be involved to other locations where vessel burglaries occurred. The vehicle was entered into the LPR hotlist and was located on Duck Key. Probable cause existed for the arrest of Daniel Aleman and Ryan Oliu as they were observed on surveillance committing a vehicle burglary a day prior. They were interrogated in which they confessed to the vehicle burglary as well as numerous other offenses. Their cellular devices were seized and examined. A text message group chat was discovered in their phones in which the suspects discuss the burglaries and plan to commit more. 21 additional arrest affidavits were generated, and the suspects were charged with them.

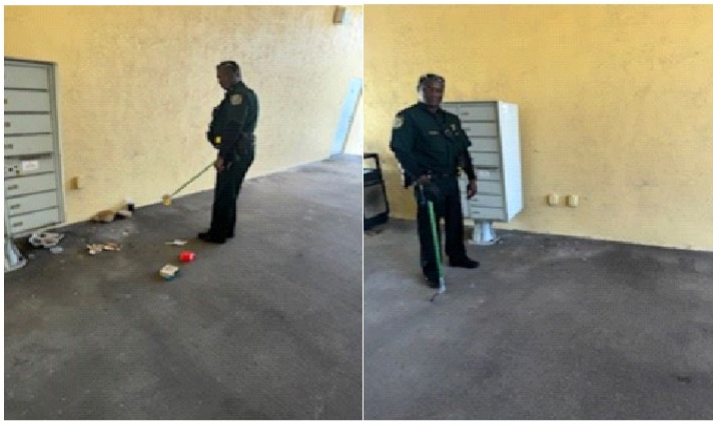
