- **B.** Discussion Regarding Proposed Speed Radar Signs Solis spoke regarding potential locations and his recommendations for the speed radar signs. Still suggested speaking with the sheriff's office and to consider the areas where there are issues. Solis explained the mobile signs capture data such as how many speeders and when. The Council commented that Harbor Drive was the issue when this was first brought up and wanted the focus to be on the neighborhoods. Solis informed the Council he would purchase four more signs to spread out in the neighborhoods.

Glen Courter, Avenue D explained that two hundred more drivers have been added to the Coco Plum area with the new apartments and the curve was extremely dangerous due to speeding cars and traffic.

C. Public Information Officer Discussion (Landry) – Landry explained we desperately need a PIO position and to be more transparent. Landry suggested a possible short-term contract until Sara Mathis is able to return. Still agreed something needed to be done and questioned if anyone had spoken with Mathis. Garrett informed everyone he has spoken with her and has reached out to a few people regarding the position and is currently defining the position, some staff are still getting a consistent message and the facts out in the meantime. Still asked that a person be hired who is trained to be a PIO as a career. Smith commented that the council ran on transparency, and we need to talk to Sara Mathis as it is important to have a professional. Still commented that it would be nice to see more people at the Council meeting. DelGaizo commented that she has the same attendance issues on her real estate board, people watch online and there is a decrease in her 600-member attendance. Landry commented that Bradley has a great handle on this and a contract would be the way to go at this time.
