

RESOLUTION NO. 02-06-76

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE CITY TO PURCHASE THREE (3) SHADE STRUCTURES FOR THE EXTREME SKATE PARK FROM SUN PORTS INTERNATIONAL, INC.; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO FINALIZE THE TERMS AND CONDITIONS OF ANY DOCUMENTATION NECESSARY TO FACILITATE SAID PURCHASE; AUTHORIZING THE MAYOR TO EXECUTE ANY DOCUMENTATION NECESSARY FOR SAID PURCHASE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Marathon ("City") desires to purchase three (3) shade structures for the Extreme Skate Park; and

WHEREAS, the shade structures would help to provide areas of relief from the heat generated by the sun, particularly during the summer months, and the asphalt surface of the park; and

WHEREAS, the proposed cost of the three (3) 20'x30' shade structures is \$10,825.00, including shipping, with the supplier being Sun Ports International, Inc. The pricing provided to the City is per the Government Services Administration Contract #GS-07F-9738H.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:


Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

conditions of any documentation necessary to facilitate said purchase, if necessary, and the Mayor is authorized to execute any documentation necessary for said purchase on behalf of the City.


Section 3. **Effective Date.** This resolution shall take effect immediately upon adoption.



SUBJECT: **Consideration of the Purchase of 3 shade structures for the Extreme Skate Park**

ITEM:

Consideration of the Purchase of 3 shade structures for the Extreme Skate Park

STATEMENT OF PURPOSE:

Purchase of 3 shade structures for the Extreme Skate Park. The shade structures would provide areas of relief from the heat generated by the summertime sun and the asphalt surface of the park.

ADDITIONAL INFORMATION:

The head of the local skate club has requested that the City consider the purchase of the shade structures to allow for more practical use of the skate park during the summer months. Staff, in cooperation with the skate club, have identified a "hip roof" design shade structure that would meet the needs of the parks. Due to layout constraints, it was identified that three structures strategically placed would provide areas of relief from the heat generated by the summertime sun and the asphalt surface of the skate park. The structures would be temporary "bolt down" structures that can and will be easily dismantled in a matter of minutes in the event of an oncoming tropical storm or hurricane and of course can be relocated with the skate park elements to a future permanent location. The cloth has an unlimited warranty of 6 years and an expected life of 10-12 years.

The cost of the three 20' x 30' structures is \$10,825.00 which includes shipping. The pricing provided to the City is per the Government Services Administration Contract # GS-07F-9738H. The installation would be by qualified volunteers.

BUDGET IMPACT:

The proposed project cost to the City is \$10,825.00. This item isn't specifically budgeted however, it has been anticipated that the Skate Park would be permanently relocated to phase II of the Community Park which is budgeted for in the City's three year Capital Improvement Plan.

The structures would be relocated with the Skate Park if and when this anticipated relocation happens.
