

**RESOLUTION NO. 02-08-119**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPOINTING AN UNSAFE STRUCTURES BOARD; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Marathon City Council ("Council") adopted Ordinance 02-07-11 (the "Ordinance") creating an Unsafe Structure's Board ("Board");

**WHEREAS**, the Council desires to appoint a Board to conduct hearings relating to unsafe structures within the City; and

**WHEREAS**, the Council finds that the establishment of the Board is in the best interests of the City.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:**

**Section 1.** **Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2.** **Appointment of Board.** The Marathon City Council hereby appoints the Board pursuant to the Ordinance.

**Section 3.** **Membership and Term.** Except as otherwise provided by this resolution, membership and term of the Board shall be as provided in Section 105 of the Standard Unsafe Building Abatement Code except as otherwise provided herein. The City Council shall appoint and remove the Board members by majority vote. The Council may remove a Board member and appoint a successor for the balance of the unexpired term. Board members shall serve without compensation or reimbursement. Should any Board member miss three (3) consecutive meetings, that Board member will automatically be disqualified and the Council shall immediately appoint a successor for the balance of the unexpired term.

**Section 4. Meetings.** Meetings of the Board shall be held as provided in the Standard Unsafe Building Abatement Code. All meetings shall be open to the public, and notice of such meetings shall be given as required for the meetings by the City Council. The Board shall record minutes at each of its meetings through its Secretary as provided in the Standard Unsafe Building Abatement Code and shall promptly provide a copy of the minutes to the City Clerk.

The Board, at its first meeting, shall organize itself by electing one (1) of its members as the chairman, one (1) member as the vice-chairman.


**Section 5. Duties.** It shall be the duty of the Board to conduct hearings of appeals of the decisions of the Building Official relating to unsafe structures within the City's jurisdiction as provided in the Standard Unsafe Building Abatement Code.

**Section 6. Appointments.** The following individuals are hereby appointed to the Board in accordance with Section 3 of this Resolution:

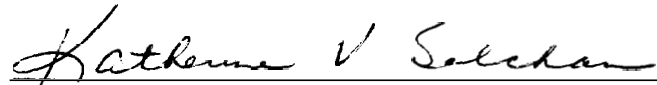
- (a) Keith Hawk (Architect) is appointed by Mayor John Bartus.
- (b) Paul Kenson (Engineer) is appointed by Vice Mayor Mearns.
- (c) Bill Kelly (Electrical Contractor) is appointed by Councilman Greenman.
- (d) Mike Cinque is appointed by Councilman Repetto.
- (e) Charles Miller (Contractor) is appointed by Councilman Worthington.

**Section 7. Effective Date.** This Resolution shall become effective immediately upon its adoption.
