## **RESOLUTION NO. 02-09-117**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING AND ADOPTING THE FINAL MILLAGE RATE OF THE CITY FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2002 AND ENDING SEPTEMBER 30, 2003, PURSUANT TO SECTION 200.065, FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 200.065, Florida Statutes, Ervin A. Higgs, Property Appraiser of Monroe County, Florida, has made tax assessments for all real property located within the boundaries of the City of Marathon, Monroe County, Florida (the "City"); and

WHEREAS, on September 23, 2002, the City Council adopted Resolution No. 02-09-112 amending Resolution 02-09-106 and adopting an "Adjusted Proposed Millage Rate" for the Fiscal Year commencing October 1, 2002 and ending September 30, 2003, and further scheduled the Final Public Hearing required by Section 200.065, Florida Statutes, to be held on Friday, September 27,2002 at 5:30 P.M.; and

WHEREAS, the public hearings, as required by Section 200.065(2)(d), Florida Statutes, were held by the City Council on the dates specified above, as previously noticed, and all interested parties have had the opportunity to address their comments to the Council; and

WHEREAS, the City Council, having considered the comments of the public regarding the final millage rate and having complied with the "TRIM" requirements of the Florida Statutes, adopts the following millage rate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:

Section 1. Final Millage Rate. That the final millage rate for the City for the Fiscal Year commencing October 1, 2002 and ending September 30, 2003 is established at the rate of 2.9645 mills, which is \$2.9645 per \$1,000.00 of taxable assessed property value for properties located within the boundaries of the City.

Section 2. Rolled Back Rate. The percentage by which this millage rate to be levied exceeds the rolled back rate of 2.6952 mills (computed pursuant to Florida Law) is 9.99 %. This is the percentage increase in property taxes adopted by the City of Marathon.

<u>Section 3.</u> <u>Effective Date.</u> This resolution shall become effective immediately upon its adoption.
