1. **JOBDESCRIPTION**

Surveying

- **A.** Miscellaneous survey services to verify existing conditions.
- **B.** Plan review for construction documents accuracy.
- C. Construction staking not included. Successful bid contractor shall be responsible for construction staking as described in the construction documents 'prepared by Calvin Giordano and Associates.
- **D.** Does not include sketch and description. Successful bid contractor shall be responsible for sketch and description as described in the construction documents prepared by Calvin Giordano and Associates.

Civil Engineering

- **A.** Prepare paving, grading and drainage, water, sewer, pavement marking and signing plans within the surveyed boundaries of the City owned Beach property.
- B. Prepare specifications and contract documents, including proposal forms, notice to bidders, general and **special** conditions, bond forms for bidding and construction.
- C. Furnish sufficient copies of drawings, specifications, and Contract Documents for review and approval by governmental agencies having jurisdiction.
- D. Process Contract Documents with appropriate regulatory agencies for the purpose of securing required permits.

- F. Coordinate with Electrical Engineer for site lighting design as required.

- I. Perform bidding services in accordance with Section 2.2 of the Professional Services Agreement. (See attached reference, <u>Continuine Services Agreement between City of Marathon and Calvin, Giordano and Associates, Inc.</u>)
- J. **Review** record drawings and prepare Engineer's certifications to appropriate regulatory agencies.

Landscape Architecture

- **A.** Prepare the final master plan, which delineates the site plan geometry for all elements. This plan shall include all parking areas, children's playground area, walks, pavers, building locations, relocated fencing, site furnishings, and other hardscape elements.
- B. Specifications for all items above as well as, safety surface, sodding areas, upper beach stabilization planting and refurbishment planting. entry access and showers.
- **C.** Prepare planting plans, derails, and specifications to be included in bidding and construction documents..
- **D.** Irrigation plans, details, and specifications to be included in bidding and construction documents. Provisions to be addressed for connection to the proposed future reclaimed water supply line in conjunction with the proposed municipal sewer line.
- E. Coordination with Architectural consultant for building design elements and construction.
- **F.** Prepare an **opinion** of construction cost based upon the completed construction drawings and specifications.
- G. **Assist** in bidding process.

Electrical Engineering Services

- C. Coordination of Florida Keys Power & Light Co. and Bell South.

Geotechnical Engineering Services

- **A.** Conduct soil test and analysis to determine soil composition, and percolution rates.
- **B.** Prepare **Geotechnical** report with recommendations for roadway and building construction.

Architectural Services

- A. Design services for the following Architectural Structures:
 - Park Shelters: 13' x 13'.
 - Park Shelters: 23' x 13'.
 - 2 architectural modifications to existing picnic structure's: 23' x 13' (these exist within the turtle nesting setback, and therefore cannot be rebuilt, only modified)
 - Metal roof and wood veneer would be anticipated for these structures.
 - 4 Restrooms (two women's, two men's and two handicapped): housed within (2) approximately 20' X 20' structures.
 - 1 Multi purpose pavilion; 30' x 30', FF at min. 4', and handicap accessible.
 - 1 Sheriffs Residence and maintenance area beneath elevated residence: Approximately 25' x 40' (approximately 1000sf of usable space)
- B. Architectural services end 15 feet beyond the building wall and do not include any site **work** All ramps, steps and boardwalks associated with the structures shall be included in the fees.
- C. Architectural construction administration is included for 100 hours.' Additional services specifically requested by the City of Marathon will be provided on an hourly as needed basis upon written authorization from the City of Marathon.
- **D.** Fees have been included for any Jurisdictional Agency reviews and permit processing.
