CITY OF MARATHON, FLORIDA RESOLUTION 2003-054

A RESOLUTION OF THE CITY COUNCIL OF THE CITY MARATHON, FLORIDA AUTHORIZING THE CITY MANAGER TO PURCHASE TWO F-150'S FORD PICKUPS AND ONE F-250 FORD PICKUP FOR THE CITY HALL, PORTS AND COMMUNITY DEVELOPMENT DEPARTMENTS

WHEREAS, the City of Marathon's 2003 approved budget appropriated funds for one Public Works vehicle; and

WHEREAS, the Ports Department and City Hall have been reimbursing employees for private vehicle use. This is not the optimal solution; and

WHEREAS, in combining the request for quotes to include all three needed vehicles, two midsized pickups for the Ports Department and City Hall and a heavy duty pickup for Public Works we obtained better quotes; and

WHEREAS, Palmetto Ford Trucks submitted the lowest prices at \$14,169 for an F-150 and \$16,186 for an F-250.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON.FLORIDA, that:

Section 1. Council authorizes the City Manager to purchase an F-150 Ford pickup for the Ports Department, an F-250 Ford pickup for the Community Development Department and a Ford Taurus or similar vehicle for the City Hall as long as the price is less than the price for the F-150 Ford pickup.

Section 2. Appropriate \$7,019 from the General Fund to Public Works Capital Outlay-Vehicles account 08.541.64.100 to cover the cost of the F-250 at \$16,186. The Ports and City Hall vehicles were not in the 2003 Fiscal Year budget. Appropriate \$14,169 from the General Fund to the Boot Key Harbor Marina Capital Outlay – Marina Equipment account 11.575.64.100 for one of the F-150 pickup. Appropriate \$14, 169 from the General Fund to the City Administration Capital Outlay - Other account 02.519.64.400 for the other F-150 pickup.

Section 3. This resolution shall take effect immediately upon its adoption.
