#### CITY OF MARATHON, FLORIDA RESOLUTION 2003-078

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING AMENDMENTS TO THE DOCKAGE RATES AND FEE SYSTEM AT THE BOOT KEY HARBOR CITY MARINA AND MOORING FIELD

**WHEREAS**, in September 2002, the council adopted a fee schedule and mooring fee system for Boot Key Harbor City Marina; and

WHEREAS, the adopted fee schedule maintained a current rate at the seawall docks that was below market rate of surrounding marinas during the winter season and did not adequately cover costs associated with electric use; and

WHEREAS, the dinghy dockage fee was also below market rate of other marinas and had not been adjusted to actual marina costs since it was transferred to the City in 2001; and

WHEREAS, the harbor mooring fee system was established as a two tier rate – short term (less than six months) stay, and a long term (over six months) stay; and

**WHEREAS**, the two tier system has proven to be difficult to manage, has created dissention with transient or cruising users, and turned away valued customers during the peak season.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

**Section 1**. Council approve the attached "Exhibit A" with supporting documentation revising the current rate schedule for dinghy dockage, seawall dockage, and mooring license fees at the Boot Key Harbor City Marina and Mooring Field.

**Section 2**. This resolution shall take effect immediately upon its adoption.

## **Boot Key Harbor City Marina**

Moorings – One rate Monthly - \$150. Weekly -\$50. Daily – \$10. Taking the two tier system away.

Dinghy - Monthly - \$60. Weekly - \$20. Daily \$4.

5/1 to 10/30 Seawall – Monthly - \$11.75 Weekly - \$6.25 Daily \$1.25

11/1 to 4/30 Seawall – Monthly - \$15.00 Weekly - \$7.50 Daily \$1.50 (All above fees include 30 Amp. Service)

Seawall - Electricity - 50 Amp. Service - \$50.00 Extra 30 Amp. Service - \$30.00 Air Conditioner - \$30.00
