RESOLUTION 2004-041**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, SUPPORTING A GRANT APPLICATION IN THE AMOUNT OF \$65,000 TO THE FLORIDA DEPARTMENT OF TRANSPORTATION ENHANCEMENT FUND FOR A DRAINAGE INJECTION WELL AT THE CORNER OF 46TH STREET GULF AND U.S. HWY. 1

WHEREAS, Florida Department of Transportation (FDOT) owns a large right-of-way through Marathon on U.S. Hwy 1; and

WHEREAS, many Marathon businesses along U.S. Hwy 1 use this right-of-way for parking; and

WHEREAS, FDOT does not consistently require these businesses to address storm water issues when improvements or repairs are made to the parking areas located within the FDOT right-of-way; and

WHEREAS, as a result the City of Marathon is experiencing storm water drainage issues at the intersection of 46th Street Gulf and U.S. Hwy. 1 in the FDOT right-of-way area; and

WHEREAS, the Florida Department of Transportation ("FDOT") Enhancement Grant cycle has opened and the City of Marathon is submitting a grant application in the amount of \$65,000 for a drainage injection well at this location; and

WHEREAS, in the event the City is awarded the requested grant, the City will be required to maintain the improvements/drainage injection well.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:


Section 1. The City Council supports the submission of a \$65,000 grant application to the FDOT Enhancement Fund to be used to fund the construction and maintenance of a drainage injection well for storm water control improvements at the intersection of 46th Street Gulf and U.S. Hwy. 1.

Section 2. The City Clerk is directed to forward a copy of this Resolution to the FDOT.

Section 3. This resolution shall take effect immediately upon its adoption.


