**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE PURCHASE OF MOTOROLA RADIOS AND REPEATER STATION EQUIPMENT FROM SUN COMMUNICATIONS FOR STAFF USE FOR EMERGENCY COMMUNICATIONS WITHIN THE CITY**

**WHEREAS**, the City of Marathon (the "City") needs to provide protection of life and property to its residents through the City's Fire Department (the "Department"); and

**WHEREAS**, the Department needs to purchase a new repeater, radios, and equipment to meet the needs of staff for emergency communications in the event of a large scale event or disaster; and

**WHEREAS**, this purchase will exceed the \$10,000 purchasing policy limit and is not budgeted in this year's fiscal budget; and

**WHEREAS**, a quote was obtained from Sun Communications, a sole source provider of this turn key system in Monroe County, in the amount of \$23,876.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**


**Section 1.** Council authorizes the purchase of Motorola radios and equipment, repeater station equipment, and antennas for an amount not to exceed \$25,000, as provided in the proposal and quote attached as Exhibit "A".

**Section 2.** The appropriation of funds from line item 001-7004-522-301 to line item 001-7004-522-604, is authorized.

**Section 3.** This resolution shall take effect immediately upon its adoption.


