**CITY OF MARATHON, FLORIDA
RESOLUTION 2004-095**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, REQUESTING THAT THE FLORIDA DEPARTMENT OF AGRICULTURE GRANT REPRESENTATIVE KEN SORENSEN'S REQUEST FOR A TEMPORARY SUSPENSION OF THE CUTTING OF CITRUS TREES WITHIN THE CITY OF MARATHON; REQUESTING A MEETING BETWEEN THE FLORIDA DEPARTMENT OF AGRICULTURE AND AFFECTED RESIDENTS

WHEREAS, the Middle Florida Keys are isolated by the 3.5 mile Long Key Bridge to the east, the Seven Mile Bridge to the west, Florida Bay to the north, and the Atlantic Ocean to the south; and

WHEREAS, the City of Marathon's corporate limits are totally contained within the Middle Keys; and

WHEREAS, according to the Department of Agriculture and the Florida Statutes, all trees within 1900 feet of a tree infected with citrus canker must be cut down to prevent the spread of the disease; and

WHEREAS, according to the Department of Agriculture's and the Florida Statutes' 1900-foot rule, not one citrus tree in Marathon is a threat to the Florida citrus industry; and

WHEREAS, many residents of the city of Marathon derive much pleasure and enjoyment of their citrus trees, including our own Key lime trees; and

WHEREAS, State Representative Ken Sorensen has requested a Temporary Suspension in citrus tree cutting from the Florida Department of Agriculture in order that they may hear the concerns of local residents; and

WHEREAS, affected local residents would request a meaningful dialogue with the Florida Department of Agriculture; and

WHEREAS, the state of Florida is running out of funds to compensate owners of trees that have been cut down by the state of Florida; and

WHEREAS, the Florida Supreme Court is considering the compensation issue in Case No. 02-1291; and

WHEREAS, the State of Florida Department of Agriculture has limited resources that would be better spent in order to achieve actual protection for Florida's citrus industry.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:


Section 1. The Marathon City Council requests that the Florida Department of Agriculture grant Representative Sorensen's Temporary Suspension of the cutting of citrus trees within the corporate limits of the city of Marathon.

Section 2. The Marathon City Council requests a meeting between the Florida Department of Agriculture and affected residents in the city so that their concerns can be heard.

Section 3. This resolution shall take effect immediately upon its adoption.


