CITY OF MARATHON, FLORIDA RESOLUTION 2004-123

A RESOLUTION OF THE CITY COUNCIL OF THE CITY MARATHON, FLORIDA, AMENDING THE RULES OF PROCEDURES FOR MEETINGS OF THE CITY COUNCIL OF THE CITY OF MARATHON

WHEREAS, the Marathon City Council discussed amending the rules of procedure at the September 28, 2004 council meeting; and

WHEREAS, at the November 13, 2002 council approved Resolution 2003-10 adopting "Rules of Procedures for Meetings of the Marathon City Council" and Resolution 2003-055 was approved on March 11, 2003 amending those rules; and

WHEREAS, per council direction amendments need to be made to Rule.2, Public Address to the City Council and Rule 3, Order of Business, the "Rules of Procedures for Meetings of the Marathon City Council".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

Section 1. Rules of Procedures for Meetings of the Marathon City Council", be amended to read;

RULE 2. PUBLIC ADDRESS TO THE CITY COUNCIL

The City Council will set aside a portion of every regular meeting for residents who wish to address the Council about items not on the agenda for the meeting. They will do so by signing up for item "11. comments on items not scheduled for public hearing and items other than those appearing on the agenda [Those who have signed in will be given the first opportunity to speak. Time is limited to 2 *3* minutes per speaker and 30 minutes total time for this agenda item.]" A resident who wishes to address the Council on a particular item on the agenda will do so by signing up for the item on which they wish to speak. Unless otherwise granted by a majority of the Council, speakers will limit their presentations on any issue or agenda item to two (2) three (3) minutes. Residents may also speak during the public hearing process under, "13. Public hearings [Limit comments to 5 minutes. Those who have signed in will be given the first opportunity to speak.]" or during "18. Citizens' comments [5 minutes per individual - Each individual has one opportunity to speak.]" near the end of the meeting.

Any individual, group, business, or agency that wishes to make a presentation to the City Council will have a City Councilmember sponsor their wishes to be placed on the agenda. Such presentations, unless otherwise approved by a majority of the Council, will be limited to five (5) minutes.

- Council comments
- Citizens' comments
- Council and administration response to citizens' comments
- Adjournment

By general consent of the Council, items may be considered out of order.

Section 2. This resolution shall take effect immediately upon its adoption.
