A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AMENDING THE SCHEDULE OF COST RECOVERY DEPOSITS ATTACHED TO RESOLUTION 01-11-77 TO REFLECT THE ADDITION OF ONE (1) NEW DESCRIPTION OF ACTIVITY AS BEING THE NON-RESIDENTIAL RATE OF GROWTH APPLICATIONS (NROGO)

WHEREAS, the City Council had originally adopted Resolution 00-11-77 implementing a cost recovery administrative program on November 8, 2000; and

WHEREAS, the City Council adopted Resolution 2003-143 on November 10, 2003, Resolution 02-07-87 on July 9, 2002, Resolution 02-10-04 on October 3, 2001, and Resolution 01-06-34 on June 12, 2001, amending the schedule of cost recovery deposits attached to Resolution 00-11-77; and

WHEREAS, the City Council finds that it is in the best interests of the residents of the City to charge the true costs for services relating to the review of applications for permits and development approvals within the City directly upon those persons deriving the benefit of the review; and

WHEREAS, the City will continually review the cost recovery deposits required and amend the amounts of the deposits to reflect expected staff time required for such reviews.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

Section 1. The attached schedule of cost recovery deposits (Exhibit "A") is hereby amended to reflect the addition of a cost recovery deposit for Non-residential Rate of Growth applications in the amount of \$600.00.

Section 2. The attached schedule of cost recovery deposits (Exhibit "A") is hereby amended to reflect the removal of a cost recovery deposit for Rate of Growth re-applications in the amount of \$250.00.

Section 3. This resolution shall take effect immediately upon its adoption.
