RESOLUTION 2005-031**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA APPROVING THE MARKET RATE RESIDENTIAL DWELLING UNIT ALLOCATION FOR QUARTER 2, YEAR 13 AND AFFORDABLE HOUSING RESIDENTIAL DWELLING UNIT ALLOCATION FOR QUARTER 2, YEAR 13 PURSUANT TO SECTION 9.5-124 OF THE CITY OF MARATHON LAND DEVELOPMENT REGULATIONS

WHEREAS, on 21st day of March, 2005, the City of Marathon (the "City") Planning Commission (the "Commission") and on the 22nd day of March, 2005, the City Council (the "Council") conducted properly advertised public hearings (the "Public Hearings") regarding the market rate and affordable housing residential dwelling unit allocations for Quarter 2, Year 13 pursuant to Section 9.5-124 of the City Code (the "Code").

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. Findings of Fact.

(1) Based upon the Staff Report, the Council approves the Planning Commission's recommendation of the ROGO applications for:

- a. Market Rate Housing – Quarter 2, Year 13 of ROGO
- b. Affordable Housing – Quarter 2, Year 13 of ROGO

(2) Based upon the Staff's Report, the Commission recommends that the City Council award allocations to applicants ranked one (1) through five (5) for Market Rate Dwelling Units, as indicated by Attachment "A"; and

(3) Based upon the Staff Report, the Commission recommends that the City Council award allocations to the applicants ranked one (1) for Affordable Rate Dwelling Units, as indicated by Attachment "A"; and

(4) The Council has duly considered the recommendation of the Commission, and the information and documentary evidence presented by members of the public, does hereby find and determine as provided below; and

(5) The Public Hearing was properly advertised and held, as required by law, and the Applicant(s) and all interested parties concerned in the matter were given an opportunity to be heard.

Section 3. Conditions.

The City Council conditions the granting of the above awards on the availability of Nutrient Reduction Credits within the city and the acceptance of any required land dedication or restrictive covenants by the City Council as required by Section 9.5-122.1(b) of the City Code.

Section 4. Conclusions of Law.

Based upon the above Findings of Fact, the Council does hereby make the following Conclusions of Law:

- (1) The ROGO applications for Quarter 2, Year 13 of ROGO have been processed in accordance with Section 9.5-122 of the Code.
- (2) In rendering its decision, as reflected in this Resolution, the Council has:
 - (a) Accorded procedural due process;
 - (b) Observed the essential requirements of the law; and
 - (c) Supported its decision by substantial competent evidence of record.
- (3) The above allocations are awarded with conditions.

Section 5. Effective Date.

That this Resolution shall become effective immediately upon its adoption.


