A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING AMENDMENTS TO THE RATES AND RENTAL FEE SCHEDULE FOR THE USE OF BOOT KEY HARBOR CITY MARINA FACILITIES

WHEREAS, on May 22, 2002 the City Council of the City of Marathon, Florida (the "Council") adopted dockage rates and a fee system for the Boot Key Harbor City Marina and mooring field (the "Marina"); and

**WHEREAS**, on May 27, 2003 the Council amended the dockage rates and fee system at the Marina; and

WHEREAS, based on a study of the prevailing market rates, the current fee schedule of the Marina was found to be below the market rate of surrounding marinas; and

**WHEREAS**, the amended fee schedule will enable the Marina to afford enhanced services to the boating public and provide for improvements to the Marina.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2.** Council approve the attached "Exhibit A" with supporting documentation revising the current rate schedule for mooring ball, seawall dockage, dinghy dockage, storage units and parking fees at the Boot Key Harbor City Marina.
  - **Section 3**. This resolution shall take effect immediately upon its adoption.
