A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, NOMINATING PROPERTY FOR ACQUISITION BY THE MONROE COUNTY COMPREHENSIVE PLAN LAND AUTHORITY FOR AFFORDABLE HOUSING

WHEREAS, it is the desire of the City Council of the City of Marathon, Florida to provide additional affordable housing within the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2.** The City Council nominates the Young Property on 23rd Street Ocean, more particularly identified in Exhibit A, for inclusion on the Land Authority Acquisition List as an affordable housing site.
- Section 3. Following acquisition, the City Council requests that the Monroe County Land Authority convey the property to the Middle Keys Community Land Trust, Inc. for management as affordable housing. Should the Monroe County Comprehensive Plan Land Authority or the Middle Keys Community Land Trust, Inc. dissolve at any time, or the property discontinue its affordable housing use, the property shall revert back to the City of Marathon.

Section 4. This resolution shall take effect immediately upon its adoption.
