A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE CITY MANAGER TO PURCHASE ONE (1) BOAT RAMP SYSTEM FROM RANDALL G. TEDDER CONSTRUCTION, INC., TO REPLACE DODGE LAKE BOAT RAMP IN AN AMOUNT NOT TO EXCEED \$68,250 AS AN EMERGENCY PURCHASE

WHEREAS, the City is in need of boat ramp repair and or/replacement for Dodge Lake and 33<sup>rd</sup> Street boat ramps; and

**WHEREAS**, the City had hired a contractor that could not complete the Dodge Lake boat ramp project and

**WHEREAS**, the boat ramp at 33<sup>rd</sup> Street cannot be replaced before the Dodge Lake boat ramp is reopened, and

WHEREAS, the above conditions constitute an "emergency purchase" situation, and

**WHEREAS,** Randall G. Tedder Construction, Inc., has been selected as a qualified, ready, willing, and able provider of a patented boat ramp system which fits the City's criteria.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2.** The City Council hereby authorizes the City to purchase the boat ramp system from Randall G. Tedder Construction, Inc., as an emergency purchase in accordance with the City procurement policy in an amount not to exceed \$68,250 as proposed, see attached exhibit "A" for replacement of the boat ramp at Dodge Lake.
  - **Section 3**. This resolution shall take effect immediately upon its adoption.

REPLACEMENT OF CITY BOAT RAMP-BEHIND MARATHON AIRPORT

This proposal is in reference to our meeting on September 28, 2006 to discuss removal and replacement of a 17'6"x60' existing boat ramp and approach way on property located behind the Marathon Airport. Our proposal and the scope of work will include the following:

#### I. REMOVE EXISTING CONCRETE BOAT RAMP

- a. Demolish and remove existing concrete boat ramp
- b. Excavate materials/soils to required elevation
- c. Stockpile all excavated materials at job site for removal by others

#### II. INSTALL NEW TEDDER BOAT RAMP SYSTEM

- a. Install a new 17'6" x45' pre-stress Tedder Boat Ramp System
- b. Level new system to proper elevation and grade
- c. Boat ramp shall have a standard non-slip rake finish (see plans)

#### III. APPROACH WAY AND TIE-IN AREA

- a. Tie-in area shall be 2'x5'x17'6" concrete filled (included in approach way area) (see plans)
- b. Approgach way shall be 17'6"x15' total
- c. Concrete shall be 6" minimum depth
- d. #4 epoxy coated rebar shall be used 12"x16" o.c. grid
- e. Surface shall be standard non-slip rake finish
- f. All concrete used shall be a 6000 psi mix at 28 days

Note: City to furnish all cylinder tests as required

#### IV. WARRANTY

- a. Owner shall be furnished with a standard five (5) year warranty upon receipt of final payment in full
- b. Owner shall be furnished with a Contractor's waiver of lien at final payment

Final payment in full shall be due to Tedder by the City of Marathon at completion of Tedder's portion of the work.
