**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
MARATHON, FLORIDA, APPROVING AN AMENDMENT TO THE
BUILDING DEPARTMENT FEE SCHEDULE TO CHANGE THE PLAN
REVIEW FEES AND FIRE INSPECTION FEES CHARGED**

WHEREAS, the City seeks to recover the costs of performing fire, building, plumbing, electrical, mechanical, and structural plan review which are covered under the last Building Code Fee adopted under Resolution 2003-063, and

WHEREAS, the City seeks to recover the cost of conducting fire safety inspections which are covered under adopted Resolution 2003-072 amending the building department fee schedule, and

WHEREAS, the City shall amend the Building Code Fee Schedule Sections E and G to read as shown on Exhibit "A"

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The Building Fee Schedule is hereby approved.

Section 3. This resolution shall take effect December 12, 2006.

2. Repeat Plans review for total footprint change or new Single Family Residence already reviewed <u>(minimum fee or hourly rate, whichever is greater)</u>	\$175.00
3. Plans Review and Revision for Commercial and Multi Family fee (Minimum fee per one hour minimum)	\$65.00
a. <u>Building Plan Review (per hour)</u>	<u>\$98.00</u>
b. <u>Mechanical Plan Review (per hour)</u>	<u>\$98.00</u>
c. <u>Electrical Plan Review (per hour)</u>	<u>\$98.00</u>
