RESOLUTION 2007-114**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE PURCHASE OF A 2007 ISUZU DIESEL DUMP TRUCK FROM GULFSTREAM ISUZU TRUCKS IN AN AMOUNT NOT TO EXCEED \$41,136; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City has contracted with the Monroe County Sheriff's Department for the services of a Deputy Sheriff and 1 to 3 inmates on a daily basis. The City pays the Deputy's salary and the inmates' services are provided at no charge; and

WHEREAS, the City has determined the best use of this labor is to take over the roadside maintenance contract. The City has recently purchased a John Deere tractor which will have a loader, a broom and a mower, to accommodate roadside maintenance. The dump truck, when purchased, will also be used for roadside maintenance as well as transporting the inmates; and

WHEREAS, three bids were received and Gulfstream Isuzu was the lowest bidder. The truck is a 2007 Isuzu 190 HP Diesel with a 14 foot landscaper aluminum dump body;


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The City hereby authorizes the purchase of the 2007 Isuzu Diesel Dump Truck from Gulfstream Isuzu Trucks in an amount not to exceed \$41,136, a copy of the purchase order is attached as Exhibit "A".

Section 2. This resolution shall take effect immediately upon its adoption,.
