RESOLUTION 2007-127**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE CITY TO ENTER INTO CHANGE ORDER # 1 WITH GONZALEZ BROTHERS LANDSCAPING, INC., IN CONNECTION WITH THE AGREEMENT DATED JULY 22, 2002, AS AMENDED ON JULY 27, 2004, AND EXTENSIONS THEREOF, FOR REFURBISHING SOCCER FIELDS AT MARATHON COMMUNITY PARK IN AN AMOUNT NOT TO EXCEED \$9,000; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City of Marathon (the “City”) owns and operates two soccer fields at Marathon Community Park; and

**WHEREAS**, storm damage and regular use of the fields have made it necessary to refurbish both soccer fields; and

**WHEREAS**, the refurbishment will consist of replacing selected sod, aerating both fields and spreading sand on both fields; and

**WHEREAS**, Gonzalez Landscaping was recently awarded the contract for park and facilities maintenance at all of the City’s parks and beaches; and

**WHEREAS**, since this contractor is and will be responsible for continued maintenance of the soccer fields, it makes sense to add this additional work to the existing contract rather than utilize competitive bidding; and

**WHEREAS**, this will allow continuity in services to the park and assure equipment, products and services used will later be maintained by the same contractor without losing guarantees and warranties from disparate service providers.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:**

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The City Council authorizes the City to enter into change order #1, a copy of which is attached hereto as “Exhibit A”, for refurbishing soccer fields at Marathon Community Park in an amount not to exceed \$9,000.

**Section 3:** The City Council authorizes the City Manager to execute the change order on behalf of the City.

**Section 4.** This resolution shall take effect immediately upon its adoption.


