RESOLUTION 2007-164**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA,
APPROVING AMENDMENTS TO THE FEES AND RATES FOR THE USE OF THE BOOT
KEY HARBOR CITY MARINA FACILITIES; AND PROVIDING AN EFFECTIVE DATE**

WHEREAS, the City of Marathon's Ordinance 02-01-08 authorizes the City to adopt by resolution fees, rules and regulations for the management and use of designated anchorage areas and mooring fields in City waters; and

WHEREAS, the Ordinance authorizes and provides that the fees may be adopted by resolution and may be amended from time to time by resolution; and

WHEREAS, the City marina fees were previously amended in November of 2006 by Resolution 2006-182 in which some rates were lowered and some rates were raised; and

WHEREAS, the attached rates were developed and used during the recent City Council budget hearings to establish revenue projections for the current fiscal year;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The City Council hereby approves the fees and rates for the use of the Boot Key Harbor City Marina facilities attached hereto as Exhibit A.

Section 3. This resolution shall take effect immediately upon its adoption. The City Council additionally directs staff to continue not charging for dinghy docks to disabled customers, as determined by the Ports Manager, pursuant to appropriate evidence thereof, until such time as the City Marina has achieved Americans with Disability Act compliance


