A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, WAIVING PROCUREMENT PROCEDURES AND APPROVING A PURCHASE FROM PRIDE ENTERPRISES FOR FURNITURE AND FIXTURES FOR FIRE STATION NO. 14 IN AN AMOUNT NOT TO EXCEED \$55,052.96; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Prison Rehabilitative Industries and Diversified Enterprises, Inc., doing business as PRIDE Enterprises, is a private not-for-profit corporation founded in 1981 which provides for job placement and other support services for ex-offenders to help them successfully transition back into society after a period of incarceration; and

**WHEREAS**, the prices and terms of purchases from PRIDE Enterprises are specified under an existing State Contract; and

**WHEREAS**, the City's adopted Purchasing Policies and Procedures allow the City Council to waive the procurement procedures and purchase materials, supplies, or equipment without competitive bidding by utilizing existing contract terms and prices specified under State Contracts; and,

**WHEREAS**, a specific furniture and fixture budget was not established for Fire Station No. 14 as it was the City's intention to use part of the construction contingency fund for this item. This amount is included in the Guaranteed Maximum Price for the fire station; and

**WHEREAS**, the City desires to purchase certain furniture and fixtures for Fire Station No. 14 from PRIDE Enterprises;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2.** The City Council hereby waives the procurement procedures requiring competitive bidding and approves the purchase from PRIDE Enterprises for furniture and fixtures for Fire Station No. 14 in an amount not to exceed \$55,052.96, a copy of the quotation attached hereto as exhibit A.
  - **Section 3**. This resolution shall take effect immediately upon its adoption.
