CITY OF MARATHON, FLORIDA RESOLUTION 2008-76

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA APPROVING THE MARKET RATE RESIDENTIAL DWELLING UNIT ALLOCATION FOR PERIOD 3, YEAR 16 AND AFFORDABLE HOUSING RESIDENTIAL DWELLING UNIT ALLOCATION FOR PERIOD 3, YEAR 16 PURSUANT TO CHAPTER 107 ARTICLE 1 OF THE CITY OF MARATHON CITY CODE

WHEREAS, on April 29, 2008, the City Council (the "Council") conducted properly advertised public hearings (the "Public Hearings") regarding the market rate and affordable residential dwelling unit allocations for Period 3, Year 16 pursuant to Chapter 107 Article 1 of the City Code (the "Code"); and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1.** The above recitals are true and correct and incorporated herein.
- **Section 2.** Based upon the information and documented evidence presented by City Staff and members of the public, the Council hereby finds:
- (1) The Public Hearings were properly advertised and held, as required by law, and the Applicant(s) and all interested parties concerned in the matter were given an opportunity to be heard; and
- (2) based upon the Staff Report, the Commission recommended that the Council award RBPAS allocations to applicants ranked one (1) through eight (8) for Market Rate General Pool, the applicants ranked one (1) and two (2) for Market Rate Owner Occupied Pool and to the applicant ranked one (1) and two (2) for Affordable Housing General Pool, as indicated by "Exhibit A and Exhibit B" hereto
- **Section 3.** The City Council conditions the granting of the above awards on the acceptance of any required land dedication or restrictive covenants by the City Council as required by Section Chapter 107 Article 1 of the Code.

Section 4. Based upon the above Findings of Fact, the Council does hereby make the following Conclusions of Law:

- (1) The RBPAS applications for Period 3, Year 16 of BPAS have been processed in accordance with Chapter 107 Article 1 of the Code.
 - (2) In rendering its decision, as reflected in this Resolution, the Council has:
 - (a) Accorded procedural due process;
 - (b) Observed the essential requirements of the law; and
 - (c) Supported its decision by substantial competent evidence of record.
 - (3) The above allocations are awarded with conditions.

Section 5. This Resolution shall become effective immediately upon its adoption.
