RESOLUTION 2008-90**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A CHANGE ORDER TO MONROE ANALYTICAL LABORATORIES AND ENVIRONMENTAL SERVICES, INC. PROFESSIONAL SERVICES AGREEMENT FOR QUARTERLY WATER QUALITY MONITORING IN THE AMOUNT OF \$7,770.00; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Marathon (the "City") entered into an agreement with Monroe Analytical Labs and Environmental Services for water quality monitoring, dated April 25, 2005, which was in effect through February 1, 2006; and

WHEREAS, the agreement contained a two year extension provision which was exercised on January 30, 2006 extending the term of the contract to February 1, 2008; and

WHEREAS, the City desires to extend the agreement retroactively from February 1, 2008 through July 31, 2008 in order to meet the quarterly water quality testing requirements of the Department of Environmental Services Lease Agreement while the City goes out to bid for another agreement; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:


Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The City Council hereby approves the Change Order to Monroe Analytical Labs and Environmental Services agreement for water quality monitoring, attached hereto as Exhibit "A", extending the agreement term and authorizing an increase in compensation the amount of \$7,770.00, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney; and authorizes the City Manager to execute the Change Order.

Section 3. This resolution shall take effect immediately upon its adoption.

This Change Order will authorize the following changes to the Agreement:


The term of the Professional Services Agreement with Monroe Analytical Laboratories and Environmental Services is extended for two additional quarters and shall remain in effect until July 31, 2008.


The Contractor shall be compensated at the quarterly rate of \$3,885.00 per quarter as specified in Section 3.1 of the Agreement. The total increase in compensation under the Agreement as a result of the extension of the term until July 31, 2008 is \$7,770.00
