RESOLUTION 2008-98**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, ACCEPTING THE QUALIFICATIONS OF RANDALL G. TEDDER CONSTRUCTION, INC. FOR RE-CONSTRUCTION OF THE QUAY BOAT RAMP AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE WITH RANDALL G. TEDDER CONSTRUCTION, INC. FOR A FINAL CONTRACT TO BE BROUGHT TO CITY COUNCIL ON JULY 8, 2008, FOR APPROVAL; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City of Marathon (the “City”) published a Request for Qualifications, which closed on May 30, 2008, for reconstruction of the Quay boat ramp; and

**WHEREAS**, a selection committee rated the three proposals that were received, and Randall G. Tedder Construction, Inc. has been selected as a qualified, ready, willing and able provider of a patented boat ramp system which fits the City’s criteria, and therefore was the highest rated of the proposals; and

**WHEREAS**, the City Council approved a Joint Project Agreement with the Florida Department of Transportation (F.D.O.T.), wherein F.D.O.T. would provide \$90,000 towards the project; and

**WHEREAS**, F.D.O.T. has concurred with the selection of the recommended contractor; and

**WHEREAS**, a contract will be negotiated and brought back to the City Council at the next regularly scheduled meeting;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**

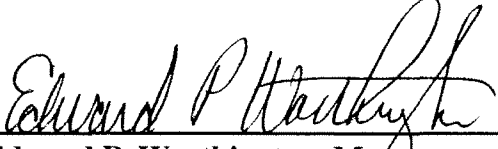
**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The City Council hereby accepts the qualifications of Randall G. Tedder Construction Inc. for re-construction of the Quay Boat Ramp and authorizes the City Manager to negotiate a final contract to be brought to City Council for approval at the July 8, 2009 City Council meeting.

**Section 3.** This resolution shall take effect immediately upon its adoption.
