RESOLUTION 2009-14**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA APPROVING THE MARKET RATE RESIDENTIAL DWELLING UNIT ALLOCATION FOR PERIOD 2, YEAR 17 AND AFFORDABLE HOUSING RESIDENTIAL DWELLING UNIT ALLOCATION FOR PERIOD 2, YEAR 17 PURSUANT TO CHAPTER 107 ARTICLE 1 OF THE CITY OF MARATHON CITY CODE

WHEREAS, on February 10, 2009, the City Council (the “Council”) conducted a properly advertised public hearing (the “Public Hearing”) regarding the market rate and affordable residential dwelling unit allocations for Period 2, Year 17 pursuant to Chapter 107 Article 1 of the City Code (the “Code”); and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. Based upon the information and documented evidence presented by City Staff and members of the public, the City Council hereby finds:

(1) The Public Hearing was properly advertised and held, as required by law, and the Applicant(s) and all interested parties concerned in the matter were given an opportunity to be heard;

(2) Based upon the Staff Report, Staff recommended that the City Council award RBPAS allocations to applicants ranked one (1) through nineteen (19) for Market Rate General Pool, the applicants ranked one (1) and two (2) for Market Rate Owner Occupied Pool, the applicant ranked one (1) and two (2) for Affordable General Pool, and to the applicant ranked one (1) for the Community Workforce Pool as indicated by “Exhibit A and Exhibit B” hereto; and

(3) Based upon the Staff Report and the Staff’s recommendations, the City Council hereby approves the allocations to the applicants ranked one (1) through nineteen (19) for Market Rate General Pool, the applicants ranked one (1) and two (2) for Market Rate Owner Occupied Pool, the applicant ranked one (1) and two (2) for Affordable General Pool, and to the applicant ranked one (1) for the Community Workforce Pool as indicated by “Exhibit A and Exhibit B” hereto.

Section 3. The City Council conditions the granting of the above awards on the acceptance of any required land dedication or restrictive covenants by the City Council as required by Chapter 107 Article 1 of the Code.


Section 4. Based upon the above Findings of Fact, the City Council does hereby make the following Conclusions of Law:

- (1) The RBPAS applications for Period 2, Year 17 of BPAS have been processed in accordance with Chapter 107 Article 1 of the Code.
- (2) In rendering its decision, as reflected in this Resolution, the City Council has:
 - (a) Accorded procedural due process;
 - (b) Observed the essential requirements of the law; and
 - (c) Supported its decision by substantial competent evidence of record.
- (3) The above allocations are awarded with conditions.

Section 5. This Resolution shall become effective immediately upon its adoption.
