A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, ACCEPTING THE RANKING AND RECOMMENDATION OF THE AUDITOR SELECTION COMMITTEE REGARDING SELECTION OF AN AUDITOR TO CONDUCT THE ANNUAL FINANCIAL AUDIT REQUIRED BY STATE LAW; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE SELECTED AUDITING FIRM; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City desires to enter into a contract for auditing services with a certified public accounting firm duly licensed under Chapter 473, *Florida Statutes*, and qualified to conduct audits in accordance with government auditing standards as adopted by the Florida Board of Accountancy; and

WHEREAS, the City established an audit selection committee which issued a request for proposals for auditing services, evaluated proposals in accordance with the auditor selection procedures outlined in Section 281.391, *Florida Statutes*, and provided its rankings and recommendation to the City Council as set forth on the attached Exhibit A; and

WHEREAS, the City desires to enter into an agreement with the selected respondent to conduct the City's annual financial audit as required by State law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**. The City Council accepts the rankings and recommendations of the audit selection committee as set forth on Exhibit "A" attached hereto and incorporated herein.
- **Section 3**. The City Council hereby authorizes the City Manager to enter into a contract with Keefe, McCullough for professional auditing services in the form attached hereto and incorporated herein as Exhibit "B;" together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney.
 - **Section 4.** This resolution shall take effect immediately upon its adoption.
