A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, ESTABLISHING PRICING FOR ADDITIONAL ENGINEERING AND/OR EQUIPMENT REQUESTED BY PRIVATE PROPERTY OWNERS IN CONNECTION WITH THE WASTEWATER SEWER SYSTEM; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Marathon (the "City") is currently in the process of constructing a wastewater collection and treatment system in the City; and

WHEREAS, in connection with the project, individual property owners may request that additional engineering and/or equipment be provided by the City's contractors with respect to their sewer connection; and

WHEREAS, the City Council wishes to establish uniform pricing across the City for such additional engineering and/or equipment;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

- **Section 1.** The above recitals are true and correct and incorporated herein.
- **Section 2**. The City Council hereby establishes the prices set forth on Exhibit A hereto as the prices for additional engineering and/or equipment to be paid by private property owners with respect to their connection to the sewer system. These prices shall apply in all the service areas in the City regardless of the actual costs for such engineering and/or equipment under the applicable contracts.
- **Section 3**. This resolution shall take effect immediately upon its adoption.
