## CITY OF MARATHON, FLORIDA RESOLUTION 2009-75

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE CITY TO ENTER INTO CHANGE ORDER #1 IN THE AMOUNT OF \$60,517.05 TO CONTRACT DATED AUGUST 12, 2008 WITH US WATER SERVICES CORPORATION (IN AN AMOUNT NOT TO EXCEED \$190,965.00) TO INCLUDE THE OPERATION OF THE AREA 6 WASTEWATER TREATMENT PLANT ON AN INTERIM BASIS AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Marathon (the "City"), pursuant to Resolution 2008-118, approved a contract with U.S. Water Corporation for operation and maintenance of the City's wastewater treatment, collection and disposal systems, on August 12, 2008 (the "Agreement"); and

WHEREAS, the Agreement expires on October 1, 2009; the Area 6 wastewater treatment plant, Wastewater & Stormwater Collection and Disposal Systems are scheduled for start up on July 1, 2009; and

WHEREAS, US Water has experience with the City's existing utilities, qualified operational and technical personnel available for the start up and operations of Area 6; and

WHEREAS, the total for this change order is \$60,517.05. This change in the contract price includes \$47,741.25 for the operation of the Area 6 facilities from July 1, 2009 to October 1, 2009 and \$12,775.80 for startup procedures of the Area 6 WWTP, Wastewater and Stormwater Collection and Disposal System which will result in a new contract price of \$251,482.05.

WHEREAS, to ensure an efficient, orderly and cost efficient start up and subsequent operations of the Area 6 facilities it would be advantageous to the City to enter into a change order agreement with US Water.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

**Section 2.** The City Council hereby authorizes Change Order # 1 a copy of which is attached hereto as "Exhibit A", in an amount of \$60,517.05 for the operation and startup procedures of the Area 6 Wastewater Treatment Plant, Wastewater and Stormwater Collection and Disposal System project in the City of Marathon.

**Section 3.** The City Council hereby authorizes the City Manager to execute Change Order #1 on behalf of the City.

Section 4. This resolution shall take effect immediately upon its adoption.
