**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE CITY TO PURCHASE A VAC-CON VACUUM TRUCK THROUGH THE FLORIDA SHERIFF'S ASSOCIATION STATE BID LIST CONTRACT (IN AN AMOUNT NOT TO EXCEED \$298,490.00) APPROPRIATING FUNDS FOR THE PROJECT AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City of Marathon ("City") is responsible for stormwater system maintenance within the City's jurisdictional limits; and

**WHEREAS**, the City needs to acquire equipment in connection with providing the service referenced above; and

**WHEREAS**, the vacuum truck will be utilized primarily for the stormwater system but, will also service the wastewater plants and wastewater collection systems; and

**WHEREAS**, this equipment is approved for purchase in the City's adopted Budget for Fiscal Year 2008-2009; and

**WHEREAS**, under the City's Purchasing Policies and Guidelines, the City may waive a competitive procurement if it bonds with an existing state or county contract for the same equipment or service that was competitively procured; and

**WHEREAS**, the City desires to take advantage of the Florida Sheriffs Association Bid List Contract #08-16-0908 in order to purchase this equipment.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The City Council hereby approves the purchase of equipment for City use under Florida Sheriffs Association Bid List Contract #08-16-0908, which is set forth on Exhibit "A" attached hereto, in an amount not to exceed \$298,490.00.

**Section 3.** This resolution shall take effect immediately upon its adoption.

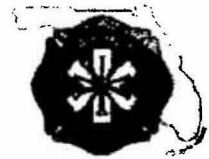

**BID 08-16-0908**

1. PURPOSE

The purpose of this bid is to establish a twelve (12) month contract, beginning October 1, 2008 and ending September 30, 2009, with manufacturer's authorized dealers for the purchase of 2009 vehicles on a "no trade-in basis". However, the Florida Sheriffs Association, Florida Association of Counties and the Florida Fire Chiefs' Association reserve the option to renew the period of this contract or any portion thereof, for an additional term not to exceed the original contract period unless the original contract period is 24 months or less, in which case the contract may be by mutual agreement renewed up to two (2) one-year periods. Renewal of the contract period shall be by mutual agreement in writing.

2. ESTIMATED QUANTITIES

In FY 2007-08 eligible users purchased over 7,000 vehicles from this bid. These estimated figures are given only as a guideline for preparing your bid and should not be construed as representing projected figures.

3. VEHICLE CONTRACT/SPECIFICATION WORKSHOP

All interested parties are invited to attend the Vehicle Workshop. At this time the contract committee members will be available to answer questions relative to this Invitation to Bid. Any suggested modifications may be presented in writing or discussed with the contract committee members at this meeting and may be considered by said representative(s) in formulating the Invitation to Bid. Should it be decided by the Cooperative Bid Coordinator to issue an addendum after the Pre-Bid Conference, it will be posted on the Florida Sheriffs Association Vehicle Bid Award System. Prospective bidders should check the web site periodically for any addendums to the solicitation documents.

Those dealers interested in participating in this year's bid should make every effort to attend this workshop to offer input and recommendations regarding the content of the contract.
