#### CITY OF MARATHON, FLORIDA RESOLUTION 2009-94

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING CHANGE ORDER NO. 10 TO GLOBETEC CONSTRUCTION LLC CONTRACT DATED AUGUST 8, 2007, IN THE ORIGINAL AMOUNT OF \$28,916,180 TO EXTEND THE FINAL COMPLETION DATE TO OCTOBER 17, 2009 AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Marathon (the "City"), pursuant to Resolution 2007-98, approved a contract with Globetec Construction LLC for Service Areas 4 & 6 collection systems for wastewater on August 8, 2007 (the "Agreement"); and

WHEREAS, the original contract called for 330 days to substantial completion and 360 days to final completion; and

WHEREAS, Globetec has been unable to meet this deadline due to the need to obtain an FDOT permit, which permit has not yet been issued through no fault of Globetec; and

**WHEREAS**, the City agrees that a change order to the Contract is appropriate that will revise the deadlines to be 534 days to substantial completion and 564 days to final completion;

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**. The City Council hereby approves Change Order #10 a copy of which is attached hereto as "Exhibit A", for a time extension to the Contract with Globetec Construction LLC for Construction of Service Areas 6 wastewater, stormwater and water reuse project in the City of Marathon.
- Section 3. The City Council hereby authorizes the City Manager to execute Change Order #10 on behalf of the City.
  - **Section 4.** This resolution shall take effect immediately upon its adoption.

Except as herein or heretofore expressly modified, all terms of the Agreement shall remain in full force and effect and shall cover the performance of, and payment for, any work authorized hereunder. Any defined terms not defined in this Change Order shall have the meanings set forth in the Agreement.


#### Backup for Change Order No. 10 GlobeTec Area 4 & 6 Collection System Contract

GlobeTec Construction has requested an extension of contract time for Contract 2, Area 6 Wastewater and Stormwater Project. The Notice to Proceed for Area 6 was issued on April 1, 2008. The original contract time was 330 calendar days to Substantial Completion and 360 calendar days to Final Completion. Change Order #5 was approved by City Council and previously granted an extension of 77 calendar days to both the Substantial Completion date and the Final Completion date. Weiler Engineering recommends granting an additional extension of 127 calendar days (86 days from today's date) to both the Substantial Completion date and the Final Completion date as summarized below:

Weiler Engineering recommends approval of this request in recognition of GlobeTec's efforts to accommodate the schedule and of their continued progress. This change in Contract time is requested in order to compensate for the delayed response from the Florida Department of Transportation concerning the review of the City's Application for an Area 6 US-1 Utility Permit. The application was provided to FDOT on April 27, 2009 (86 days ago) and no permit has been issued nor has any response relating to this permit been received. GlobeTec Construction is unable to begin work on US-1 in Area 6 until the City obtains the required permit from FDOT.

Weiler Engineering and GlobeTec Construction acknowledge and agree that, should the FDOT permit not be obtained by August 10, 2009, the Area 6 schedule may be further impacted. Should this occur, GlobeTec may be entitled to further time extension for Contract 2, the Area 6 Contract. The amount of time due, if any, will be included in a separate change order from this one.

RE: Change Order No. 10

Mr. Fonte:

This letter is intended to clarify the terms of Change Order No. 10 which was a time extension for the Areas 6 construction contract. That change order approvs an extension of 127 additional calendar days, moving the substantial completion date to September 17, 2009. The intent of the change order was to provide an interim extension to your contract until such time as the FDOT permit for the construction in the US 1 corridor is issued. At that time, we will negotiate an extension with Globetec based on the scope of work and on the terms and conditions of the FDOT permit. It is understood that until the permit conditions are known, it will not be possible to determine the time required to perform the modified scope of work.

Change Order No. 10 provides a mechanism to extend the substantial completion date sufficiently to allow for issuance of the FDOT permit and for execution of the an additional change order extending the time to accommodate the changed work in accordance with the contract documents. Without the interim extension, the term of the contract would be exceeded. Change Order No. 10 was approved by Council and needs to be executed in that form. Note that the contract amount in the Change Order is the ORIGINAL contract amount, not the amount as modified by previous change orders.
