A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA APPROVING AMENDMENT # 1 TO FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) LOCAL AGENCY PROGRAM AGREEMENT (LAP) NO. APW63 DATED APRIL 21, 2010, IN THE ORIGINAL AMOUNT OF \$95,000, REDUCING EARMARK AWARD AMOUNT BY \$6,080 FOR A NEW TOTAL AGREEMENT OF \$88,920; AUTHORIZING THE CITY MANAGER TO SIGN THE AGREEMENT ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Marathon (the "City") was allocated \$95,000 in a Federal Government appropriation in fiscal year 2008/2009 for use in constructing and operating the City's stormwater utility; and

WHEREAS, the Florida Department of Transportation (the "FDOT") was designated as the State Agency to oversee dispersal of the Federal Government appropriation; and

WHEREAS, the FDOT requires that recipients of said Federal Government appropriation to enter into a Standard Local Agency Program Agreement; and

WHEREAS, the Federal Government appropriation has been reduced in the amount of \$6,080.00, and as a result, the Local Agency Program Agreement is subject to a corresponding reduction.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

**Section 2.** The first amendment to the FDOT Local Agency Program Agreement between the City and FDOT, a copy of which is attached hereto as Exhibit "A" is hereby approved The City Manager is authorized to execute the First Amendment on behalf of the City.

Section 3. This resolution shall take effect immediately upon its adoption.
