RESOLUTION 2010-29**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA PURSUANT TO CHAPTER 107, ARTICLE 1 APPROVING THE FINAL RANKINGS AND ALLOCATION OF THE MARKET RATE AND AFFORDABLE RESIDENTIAL DWELLING UNIT APPLICATIONS FOR PERIOD 2, YEAR 18 UNDER THE TEMPORARY RBPAS PROCEDURES PROMULGATED IN SECTION 107.07 G OF THE CITY OF MARATHON CITY CODE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, on March 23, 2010, the Council reviewed the market rate and affordable residential dwelling unit application rankings for Period 2, Year 18 for the purposes of initiating the Temporary BPAS procedures promulgated in Section 107.07 G of the Land Development Regulations;

WHEREAS, the City of Marathon (the "City") conducted a properly advertised public hearing (the "Public Hearing") regarding the proposed residential BPAS rankings, Period 2 Year 18 pursuant to Chapter 107 Article 1 of the City Code (the "Code"),

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. Based upon the information and documented evidence presented by City Staff and members of the public, the City Council hereby finds:

Residential Building Permit Allocation (RBPAS)

(1) The Public Hearing was properly advertised and held, as required by law, and the Applicant and all interested parties concerned in the matter were given an opportunity to be heard; and

(1) Based upon the RBPAS Rankings shown in the staff recommendation, attached as "Exhibits 1 & 2" for the Market Rate and Affordable RBPAS pools, City Council awards five (5) Market Rate allocations and zero (0) Affordable Allocations based upon a willingness to build immediately. Remaining BPAS Applicants will retain their relative positions in the BPAS ranking list and will be deferred in accordance with Section 107.07 of the Land Development Regulations.

Section 3. Based upon the above Findings of Fact, the City Council does hereby make the following Conclusions of Law:

(1) The RBPAS applications for Period 2, Year 18 have been processed in accordance with Chapter 107 Article 1 of the Code.

- (2) In rendering its decision, as reflected in this Resolution, the City Council has:
- (a) Accorded procedural due process;
 - (b) Observed the essential requirements of the law; and
 - (c) Supported its decision by substantial competent evidence of record.

(3) The attached RBPAS allocations are awarded.

Section 4. This Resolution shall become effective immediately upon its adoption.
