

**CITY OF MARATHON, FLORIDA
RESOLUTION 2010-62**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE CITY TO ENTER INTO A ONE YEAR EXTENSION OF THE FIRE RESCUE – EMS MEDICAL DIRECTOR AGREEMENT WITH PROFESSIONAL EMERGENCY SERVICES, INC., IN AN AMOUNT NOT TO EXCEED \$27,520; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Marathon, Florida (the “City”) is responsible for providing emergency medical service within the City boundaries; and

WHEREAS, the City is required by Chapter 401, *Florida Statutes*, to contract with a licensed physician to serve as the City’s “Medical Director,” also referred to as the “Fire Department Physician;” and

WHEREAS, Professional Emergency Services, Inc., is in business of providing medical director services and meets the requirements of Florida Statutes; and

WHEREAS, the City currently contracts with the Consultant for these services, and the present contract expires on September 30, 2010, and the City and Consultant desire to extend the Agreement for an additional year in an amount not to exceed \$27,520 to be paid in twelve monthly installments of \$2,293.33.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The Agreement between the City and Professional Emergency Services, Inc., is hereby extended for one year commencing on October 1, 2010 and terminating on September 30, 2011, in an amount not to exceed \$27,520 to be paid in twelve monthly installments of \$2,293.33.

Section 3. This resolution shall take effect immediately upon its adoption.
