## CITY OF MARATHON, FLORIDA RESOLUTION 2010-67

A RESOLUTION OF THE CITY OF MARATHON, FLORIDA, APPROVING CHANGE ORDER NO. 2 AND 3 TO CONTRACT DATED DECEMBER 14, 2009 (IN THE ORIGINAL AMOUNT OF \$856,366.71) WITH ATLANTIC CIVIL, INC. FOR CONSTRUCTION OF THE SOMBRERO BEACH ROAD EXTENSION PROJECT; INCREASING THE CONTRACT IN AN AMOUNT NOT TO EXCEED \$98,006.54, AND EXTENDING THE CONTRACT TIME BY 69 DAYS; AUTHORIZING THE CITY MANAGER TO EXECUTE THE CHANGE ORDERS ON BEHALF OF THE CITY, AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in December of 2009, the City of Marathon (the "City") entered into a contract with Atlantic Civil, Inc ("ACI") for construction of the Sombrero Beach Road Extension Project ("Contract"); and

WHEREAS, upon commencement of construction, several water main, stormwater and wastewater line conflicts, and other issues were identified requiring additional work to accommodate the proposed storm sewer system; and

WHEREAS, Change Order No. 2 is an additive change order to the Contract, increasing the contract in the amount of \$77,673.37, and extending the contract completion date by 43 days; and

WHEREAS, Change Order No. 3 is an additive change order to the Contract, increasing the contract in the amount of \$20,333.17, and extending the contract completion date by 26 days; and

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

**Section 2**. Change Orders No. 2 and No. 3, to the Contract between the City and ACI in an amount not to exceed \$98,006.54 and extending the contract completion date by 69 days, attached hereto as "Exhibit A," together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney is hereby approved. The City Council hereby authorizes the City Manager to execute the Change Orders on behalf of the City and expend funds.

Section 3. This resolution shall take effect immediately upon its adoption.



#### Item Narrative

Upon commencement of construction, several conflicts were determined with the depth of an existing water main, sanitary lines and storm sewer, requiring several additional fittings to accommodate the proposed storm sewer system. The water main depth also presented an issue with construction activities over the shallow line, and additional measures are required to protect the water main. Severe erosion caused by the weather at the western most end of the beach was determined to be an issue, and best corrected under this project, as well as a needed retaining wall for adjustment due to severe grade changes within private property adjacent to the R/W. Additional work is required to provide a transition to the recently completed Sombrero Beach Road, which said work was completed after these plans were completed.

#### Item Narrative

Prior to the commencement of construction, the City installed a reclaim water main along Sombrero Beach Road to Avenida Primacera. The reclaim water line needs to be extended further down Sombrero Beach Road to the existing connection point of the Park's irrigation system. This work is best accomplished by the contractor already mobilized on site, and will eliminate disturbance to the newly constructed facilities at a later date.
