**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AMENDING THE CITY'S WASTEWATER UTILITY RATE SCHEDULE TO ADD A NEW CLASS OF WASTEWATER SERVICES FOR "LAUNDROMATS" AND A CORRESPONDING FEE; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Marathon, Florida (the "City") enacted Ordinance 02-07-12 and Ordinance 2008-10, which establish a Wastewater Utility and authorizes by City Council resolution, the creation of different classes of wastewater services and the imposition of fees, charges, and procedures as appropriate for the construction, operation and maintenance of the Wastewater Utility; and

**WHEREAS**, based upon input from the City's residents and City staff, the City Council has determined that laundromats provide an essential service to the businesses and residents of the City; and

**WHEREAS**, the City desires to amend the Wastewater Utility Rate Schedule by adding a new class, "Laundromats," and a corresponding wastewater service fee for Laundromats.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:**


**Section 1.** The above recitals are true and correct and are incorporated herein.

**Section 2.** The amended Wastewater Utility Rate Schedule, which includes a new class entitled "Laundromats," attached hereto as "Exhibit A" is hereby adopted.

**CLASS: LAUNDROMATS**

The following rates apply to facilities defined herein as a "Laundromat."

"Laundromat" means a stand-alone laundry business with coin operated washing machines that provide self-service and non-self-service laundry facilities to the public, consisting of washing machines, dry cleaning machines, and clothing dryers, in any combination. "Laundromat" does not include laundry facilities that are located in or otherwise associated with a hotel, motel, or other similar facilities.

**Monthly Rates for Laundromats:**

---

1. <u>Capital Costs:</u>	<u>((EDU × 75% Discount) × \$,4681) ÷ 20) ÷ 12)</u>
2. <u>Base Facility Charge:</u>	<u>((EDU × 75% Discount) × \$21.78)</u>
3. <u>Customer Charge:</u>	<u>\$14.19</u>
4. <u>Volumetric Charge:</u>	<u>\$8.04 (Per 1,000 gallons of metered water service)</u>
