### CITY OF MARATHON, FLORIDA RESOLUTION 2018-04

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING REPAIRS TO BE COMPLETED BY SOLE SOURCE VENDOR, CENTRISYS CENTRIFUGE SYSTEMS, PURSUANT TO THE CITY'S PURCHASING POLICIES AND PROCEDURES AND APPROVING THE REPAIRS TO THE CS21-4HC CENTRIFUGE, IN THE AMOUNT NOT TO EXCEED \$72,050.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE CONTRACT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Ordinance 2015-04, the City adopted purchasing policies and procedures (the "Purchasing Policies and Procedures") after determining that it was fiscally prudent and in the City's best interest to adopt policies and procedures for City employees and officials regarding the acquisition and purchase of contractual services, equipment, goods, and other similar types of services; and

WHEREAS, the Purchasing Policies and Procedures allow the City Council to enter into contracts for materials, supplies, equipment, public improvements or services without competitive bidding after conducting a good faith review of available *sources*, finding that there is only one *source* for the required supply, brand, service, or construction item capable of fulfilling the needs of the City; and

WHEREAS, the CS21-4 HC Centrifuge was damaged due to wind and storm surge during hurricane Irma. The Centrifuge is a vital component in the dewatering at the wastewater treatment plants and Centrisys Centrifuge Systems is the manufacture and sole source repair service for the unit. Repairs are shown on EXHIBIT "A" in an amount not to exceed \$72,050.00.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1.** The above recitals are true and correct and incorporated herein.
- **Section 2.** The City Council hereby authorizes the City Manager to enter into an agreement and expend budgeted funds on behalf of the City for the Sole Source repairs to the CS21-4 HC Centrifuge and trailer in an amount not to exceed \$72,050.00.
  - **Section 3**. This resolution shall take effect immediately upon its adoption.

The following is an estimate for the repair of the mobile dewatering skid at Marathon, FL.

As the unit is not able to be moved due to damaged hydraulics and possibly compromised brakes, bearings and suspension, we recommend the following:

We will have a 40 ton crane remove the CS21-4 HC from the existing trailer and load it onto a "double drop".

We will send the damaged flatbed trailer to a trailer repair company out of Miami, FL for repairs.

Once the CS21-4 HC arrives in Kenosha on the drop deck trailer, we will move your machine to the Centrisys repair facility to inspect and quote a full repair.
