**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A PURCHASE ORDER FOR “VACUUM SEWER INFRASTRUCTURE” TO THIRD GENERATION PLUMBING IN THE AMOUNT OF \$36,820.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE CONTRACT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Marathon (the “City”) requested pricing from three vendors for “Vacuum Sewer Infrastructure for 1655 Overseas Highway”, (the “Project”); we received two bids; and;

**WHEREAS**, the lowest bid that was found to be responsive and responsible was received from Third Generation Plumbing in the amount of \$36,820.00; and

**WHEREAS**, the City staff wish to enter into a contract with Third Generation Plumbing in order to provide vacuum sewer infrastructure for 1655 Overseas Highway;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**

**Section 1.** The foregoing recitals are true and correct and are incorporated herein by this reference.

**Section 2.** The proposal attached hereto as Exhibit “A”, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney is hereby approved and will be executed through a purchase order. The City Manager is authorized to sign the purchase order and expend budgeted funds on behalf of the City.

**Section 3.** This resolution shall take effect immediately upon its adoption.



- Install (5) air intake vents
- Install 200' of 4" Vacuum main
- Compaction of excavated area
- Pavement restoration not included
