RESOLUTION 2014-05**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING A “PIGGY BACK PURCHASE” PURSUANT TO THE CITY’S PROCUREMENT POLICIES AND PROCEDURES AND AUTHORIZING THE PURCHASE OF A FIRE RESCUE VEHICLE FROM THE FLORIDA SHERIFF’S CONTRACT BID #11-10-1202 SPECIFICATION TYPE I FIRE RESCUE VEHICLE, IN AN AMOUNT NOT TO EXCEED \$267,411.07; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution 2003-134, the City adopted purchasing policies and procedures (the “Purchasing Policies and Procedures”) after determining that it was fiscally prudent and in the City’s best interest to adopt policies and procedures for City employees and officials regarding the acquisition and purchase of contractual services, equipment, goods, and other similar types of services; and

WHEREAS, the Purchasing Policies and Procedures allow the City Council to enter into contracts for materials, supplies, equipment, public improvements or services without competitive bidding by utilizing existing contract terms and prices entered into by other local, state or federal governmental authorities that followed a competitive bidding procedure leading to the award of the contract in question; and

WHEREAS, ambulance rescue unit 214 has exceeded its service life and the City desires to acquire a type I Fire Rescue Vehicle to replace rescue unit 214 to meet the demands and continue the high level of service and safety to the City and its residents; and

WHEREAS, the \$267,411.07 cost of the Type I Fire Rescue Vehicle is based on the competitively bid Florida Sheriff’s Association Bid #11-10-1202, as required by the Purchasing Policies and Procedures.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The City Council authorizes the City Manager to expend budgeted funds with Emergency Tactical Rescue Vehicles for the purchase of a Type I Fire Rescue Vehicle in an amount not to exceed \$267,411.07 based on the competitively bid Florida Sheriff’s Association Bid #11-10-1202.

Section 3. This resolution shall take effect immediately upon its adoption.
