A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING THE INSURANCE PREMIUM FOR GENERAL LIABILITY, AUTO LIABILITY, AUTO PHYSICAL DAMAGE, PROPERTY AND WORKERS COMPENSATION INSURANCE FOR THE CITY COVERAGE TO FLORIDA LEAGUE OF CITIES, FLORIDA MUNICIPAL INSURANCE TRUST (FMIT) IN THE ANNUAL AMOUNT OF \$265,270; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Marathon, Florida (the "City") has determined that it is fiscally prudent and in the best interests of the City's residents for the City to renew the insurance for general liability, auto physical damage and property; and

WHEREAS, the City will also renew insurance as legally required for workers compensation and auto liability; and

WHEREAS, the City Manager recommends the City Council approve the amounts as shown on Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Based upon the recommendation of the City Manager the City Council finds the renewal of insurance premiums for the City's insurance, in an amount of \$265,270.00 in four installments is in the best interest of the City.

Section 3. The City Manager or is authorized to execute the installments of insurance premium as seen in Exhibit "A," and expend budgeted funds on behalf of the City.

Section 4. This resolution shall take effect immediately upon its adoption.
