Section 2. An amendment to the contract agreement between the City and the Contractor, attached hereto as Exhibit "A," together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney is hereby approved. The City Manager is authorized to sign the amendment and expend budgeted funds on behalf of the City.

Section 3. This resolution shall take effect immediately upon its adoption.

AMENDMENT TO CONTRACT BETWEEN THE CITY OF MARATHON, FLORIDA AND ADVENTURE ENVIRONMENTAL, INC. FOR MANGROVE TRIMMING SERVICES
