A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, ACCEPTING THE RANKING AND RECOMMENDATION OF THE CITY'S EVALUATION TEAM FOR CONSTRUCTION MANAGEMENT SERVICES FIRMS; AUTHORIZING THE CITY MANAGER TO NEGOTIATE CONTRACTS WITH THE TOP TWO FIRMS FOR CONTINUING CONSTRUCTION MANAGEMENT SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Manager established an "Evaluation Team" consisting of City Staff to review, evaluate and rank proposals in accordance with the RFP criteria; and

WHEREAS, on October 15,2014 the City Clerk received nine (9) responses to the RFP which were subsequently reviewed and evaluated by the City's Evaluation Team; and

WHEREAS, the City Manager wishes to rank the firms and authorize the City Manager to negotiate contracts with the top two (2) firms as provided on Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**. The City Council accepts the City's Evaluation Team ranking for Construction Management Service Firms and authorizes the City Manager to negotiate contracts with the top two firms as provided on Exhibit "A".
 - **Section 3.** This resolution shall take effect immediately upon its adoption.
