**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
MARATHON, FLORIDA, AMENDING THE BUILDING DEPARTMENT
FEE SCHEDULE TO REVISE PLAN REVIEW AND FIRE INSPECTION
FEES**

WHEREAS, the City of Marathon (the“City”) is authorized by State law to recover the associated costs of performing building plans review, permitting and inspection services for building and development activity in the City, and as authorized by State law has adopted a Building Department Permit Fee Schedule; and

WHEREAS, the City desires to amend the Building Code Fee Schedule to revise the costs of performing fire safety inspections and plan review to include estimated direct costs for review of building plans and fire inspection for applications for permits issued by the City.

WHEREAS, the City desires to amend the Building Code Fee Schedule under the Fire / Life- Safety Permits and Plan Review fees as set forth on Exhibit “A”

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF MARATHON, FLORIDA**, that:


Section 1. The above recitals are true and correct and are incorporated herein by this reference.





FIRE / LIFE-SAFETY PERMITS AND PLAN REVIEW FEES

Minimum Fee	\$98.00 – <u>\$110.00</u>
Residential and commercial fire protection and fire alarm systems (contract price)	\$20.00 per \$1,000.00
<u>Everything over \$5,500 will be \$20.00 per \$1,000.00</u>	
<u>New Commercial Construction, Additions, Alterations and Repairs</u>	
<u>Total cost of project minimum fee \$110.00 everything over \$22,000 will be \$5.00 per \$1,000.00</u>	
	<u>\$5.00 per \$1000</u>
Fire/Life-Safety Inspection; per Floor Level/per Inspection and Related Testing	\$85.00 –\$110.00
<u>Miscellaneous fees:</u>	
a. <u>Re-inspection fee, each re-inspection of a construction site due to contractor error</u>	<u>\$150.00</u>
b. <u>Work performed without a permit –All fees doubled</u>	<u>All fees doubled</u>
