A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE PURCHASE OF TWO DELL EQUALLOGIC PS6210X STORAGE AREA NETWORK 1.2 TB 10K SAS DRIVES FOR THE NEW CITY HALL AT A TOTAL COST OF \$96,518.66 INCLUDING LABOR AND SHIPPING PURSUANT TO THE CITY'S PURCHASING POLICIES AND PROCEDURES; AUTHORIZING THE CITY MANAGER TO ENTER INTO AGREEMENTS IN CONNECTION THEREWITH, EXPENDING BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, pursuant to Ordinance 2015-04, the City adopted purchasing policies and procedures (the "Purchasing Policies and Procedures") after determining that it was fiscally prudent and in the City's best interest to adopt policies and procedures for City employees and officials regarding the acquisition and purchase of contractual services, equipment, goods, and other similar types of services; and

WHEREAS, the Purchasing Policies and Procedures allow the City Council to enter into contracts for materials, supplies, equipment, public improvements or services without competitive bidding by utilizing existing contract terms and prices entered into by other local, state or federal governmental authorities that followed a competitive bidding procedure leading to the award of the contract in question; and

WHEREAS, funds have been budgeted in year 2015-16 for the purchase of two Dell Equallogic PS6210X Storage Area Network 1.2 TB 10K SAS Drives, and

WHEREAS, the City desires to take advantage of the State Contract for the purchase of Dell computers, a quote through the City's Contractor ENS, Inc. is attached as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2.** The City Council hereby authorizes the City Manager to purchase two Dell Equallogic PS6210X storage area network 1.2 TB 10K SAS drives under state contract number WN05ACA for the new city hall at a total cost of \$96,518.66 including labor and shipping pursuant to the quote provided by ENS, Exhibit "A."
 - **Section 3**. This resolution shall take effect immediately upon its adoption.
