RESOLUTION 2015-138**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, RATYFING AN EXTENSION TO THE CONTRACT FOR BEACH RAKING SERVICES BETWEEN THE CITY AND W.D. THOMPSON, INC., D/B/A BEACH RAKER, TO EXTEND SAME FOR A ONE-YEAR PERIOD; AUTHORIZING THE RATIFICATION OF THE EXTENSION AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, pursuant to Resolution 2013-47, the City and W.D. Thompson, Inc., d/b/a/ Beach Raker (“Beach Raker”) entered into a contract for beach cleaning service for CocoPlum and Sombrero Beaches, with four one year renewal options to coincide with the Florida Department of Environmental Protection five (5) year beach cleaning permit (the “Contract”); and

**WHEREAS**, the contract contains the provisions for an extension of one (1) year, to and through September 31, 2016.

**WHEREAS**, the City and Beach Raker desire to extend the Contract.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** An extension to the Contract between the City and Beach Raker, attached hereto as Exhibit “A,” together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney is hereby approved. The City Manager is authorized to sign the extension and expend budgeted funds on behalf of the City.

**Section 3.** This resolution shall take effect immediately upon its adoption.
