Section 1. The above recitals are true and correct and incorporated herein.

**Section 2.** Sombrero Country Club, Inc. assigns all its rights and obligations under the aforesaid Development Agreement to Florida Keys Resort Holdings, LLC.

**Section 3.** Florida Keys Resort Holdings, LLC accepts the assignment and agrees to perform all rights, duties, and obligations of the Development Agreement.


