RESOLUTION 2015-17**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A CHANGE ORDER TO THE CONTRACT BETWEEN THE CITY OF MARATHON AND AMERICAN UNDERWATER CONTRACTORS, INC. IN THE AMOUNT OF \$56,795.20 FOR THE SUPPLY OF AN ADDITIONAL 55 MOORING BALL DOWN LINE ASSEMBLIES; AUTHORIZING THE CITY MANAGER TO EXECUTE THE CHANGE ORDER; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, a bid was issued for the Mooring down line assemblies that needed to be replaced in 2014; and

**WHEREAS**, the sole bid for the assemblies was obtained from American Underwater Contractors, Inc. of Tequesta, Florida on May 16, 2014 in the amount of \$77,448; and

**WHEREAS**, in May and October of 2014, the City Council approved Resolutions 2014-54 and 2014-127, awarding the contract to American Underwater Contractors, Inc.; and

**WHEREAS**, the Florida Fish and Wild life Conservation Commission which partially funds this purchase has extended the grant for remainder of this phase of the mooring units in Boot Key Harbor; and

**WHEREAS**, this change order for an additional 55 mooring systems will complete phase II of the mooring field refurbishment and enable the City to invoice in 2015 for the remainder of the grant reimbursement.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:**


**Section 1.** The City Council hereby approves a change order to the purchase contract to American Underwater Contractors, Inc. for the supply of an additional 55 mooring ball assemblies in the amount of \$56,795.20.

**Section 2.** The City Manager is authorized to execute the Change Order and expend budgeted funds on behalf of the City.

**Section 3.** This resolution shall take effect immediately upon its adoption.
