RESOLUTION 2015-28**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING THE PURCHASE OF AN ISUZU LANDSCAPE DUMP TRUCK, AUTHORIZING THE CITY MANAGER TO EXECUTE A PURCHASE ORDER IN THE AMOUNT OF \$43,439.00 WITH ISUZU TRUCK OF OCALA AND EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as part of the regular City vehicle replacement program, the Public Works Isuzu Landscape Dump Truck is due for replacement as it has exceeded its seven year life expectancy as the vehicle was purchased in 2007; and

WHEREAS, the Florida Sheriffs' Association issued a competitive procurement Invitation to Bid No. 14-12-0904 for the purchase of vehicles on a state-wide basis and awarded a contract to Isuzu Truck of Ocala; and

WHEREAS, the City desires to take advantage of the Florida Sheriffs' Association contract to purchase a 2015 Isuzu NS454 Dump Truck in the amount of \$58,439.00; and

WHEREAS, the dealer is giving a trade-in credit of \$15,000.00 for the existing truck, which brings the total purchase cost to \$43,439.00; and

WHEREAS, this equipment is approved for purchase in the City's adopted budget for Fiscal Year 2014-2015.



Section 1. The City hereby authorizes the purchase of the 2015 Isuzu ns454 Dump Truck from Isuzu Truck of Ocala in an amount not to exceed \$43,439.00, a copy of the quote is attached as Exhibit "A".


