**CITY OF MARATHON, FLORIDA
RESOLUTION 2016-41**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AMENDING THE BUILDING DEPARTMENT FEE SCHEDULE TO ESTABLISH ADMINISTRATIVE FEES FOR SCHEDULED BUILDING PERMITS AND AN EDUCATIONAL FEE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Marathon (the "City") is authorized by State law to recover the associated costs of performing building plans review, permitting and inspection services for building and development activity in the City, and as authorized by State law has adopted a Building Department Permit Fee Schedule; and

WHEREAS, the City desires to amend the Building Code Fee Schedule to revise the costs of performing building inspections performed after hours and time specific inspections; and

WHEREAS, the City desires to amend the Building Code Fee Schedule to include an education fee for the training and recertification of building department staff pursuant to Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The Building Fee Schedule attached hereto as Exhibit "A" is hereby approved. All Building Code Fee Schedules or parts of Building Code Fee Schedules in conflict with the provisions of this Resolution are hereby repealed.

Section 3. This resolution shall take effect immediately upon adoption.


